### ***Fall 2008- General Financial Aid Transmittal and Remainder Fund Processing Dates***

1. Tuition Payment will begin approximately on January 12, 2009.
2. Loan only students (students who do not qualify for other means of aid, such as a pell grant or state aid/scholarships) are required to make payment arrangements in the cashier's office.
3. 1<sup>st</sup> Disbursement for books and supplies will begin on January 14, 2009. All students must have a disbursement method set up in eConnect to receive any remainder funds eligible, based on enrollment level and payment of tuition. 4. 2<sup>nd</sup> Disbursement processing begins February 9, 2009, after financial aid lock out date (12<sup>th</sup> class day), and attendance certification processes have been complete; to include Stafford loan funds.
